

**NURSERY, PRE-SCHOOL, PRE-K AND T-K RESERVATION AGREEMENT**

After the receipt of the initial Registration/Supply Fee and this reservation agreement due on or before March 1, 2017, the above named student is registered for the 2017-2018 school year at Julie Rohr Academy. All Registration/Supply Fees are non-refundable, due in the amount indicated:

One-third of the Registration/Supply Fee is due upon registration on or before March 1, 2017, for current students, with the other two-thirds payable in two equal installments on the 3<sup>rd</sup> day of April and the 1<sup>st</sup> day of June 2017. For those registering after March 1, 2017, the registration fee will be due in three equal monthly installments with the first one due upon registration.

Rates for tuition are based on the number of academic hours the child attends school. Any additional hours are considered extended care and are charged at one rate only. Operating hours of the school are from 6:30 AM until 6:00 PM. Tuition is charged for 41 weeks. **(INCLUDING ALL HOLIDAYS, RECREATION DAYS, AND WINTER AND SPRING BREAK WEEKS)** per academic year. The second child in the family receives a 20% discount. The third child in the family receives a 30% discount. The oldest child is the first child. Annual and semester payments are due on or before July 3, 2017. Second semester payments are due on or before December 15, 2017. Monthly payments are divided into 9.5 monthly installments with the half month due on August 14<sup>th</sup>, and the remaining 9 months due on or before the 1<sup>st</sup> of each month beginning September 1, 2017, and ending May 1, 2018. Weekly payments are due on or before Monday of each week. In order to meet our expenses we must have tuition paid on or before the day it is due. A late fee of \$15 for any unpaid balance of over \$200 and \$30 for any unpaid balances over \$400 will be added on the 5<sup>th</sup> and 20<sup>th</sup> of each month. Any account that remains unpaid by the last day of the month will have admission suspended until past balances are remitted. The JRA school year begins August 14<sup>th</sup>, and ends May 25<sup>th</sup>.

**Accounts must be paid on or before the due date.** A late fee of \$15 for any unpaid balance of over \$200 and \$30 for any unpaid balances over \$400 will be added on the 5<sup>th</sup> and 20<sup>th</sup> of each month. Any student whose account is not paid by the last day of the month will not be permitted to attend classes until the account is current. It is understood that tuition and extended care payments are required when the child is absent from school and during all vacations, holidays, recreation days, and winter and spring break weeks through the academic year.
